POSITION PURPOSE

Social Action refers to the active engagement in social justice and philanthropic initiatives on local, national and global levels.

The Head of Social Action, Global Citizenship and Engagement will actively influence the quality and advancement of strong, ongoing relationships and partnerships with the Social Justice & Philanthropic community; developing and facilitating sustainable programs that will support the College's Service framework.

The Head of Social Action, Global Citizenship and Engagement has the responsibility for strengthening resources and external supports for the St Leonard's College Social Action engagement.

The Head of Social Action, Global Citizenship and Engagement will provide dynamic and innovative leadership and direction, set high expectations and ensure excellence in the quality of the Social Action programme.

The Head of Social Action, Global Citizenship and Engagement will actively promote awareness about Social Justice issues and assist the College in determining the relevant outreach, non-profit and awareness programs and how to best become socially responsive to the needs of our local, national and global communities.

POSITION STATUS

This is initially a contract part time position with five weeks' annual leave, to be taken in term breaks, plus College deemed shut down days, usually four per year.

Due to the nature of the role some weekend and evening work will be required.

Major Duties and Responsibilities

- In consultation with the Principal, the Head of Social Action, Global Citizenship and Engagement will embed principles of equity and social justice in policy, practices and decision-making at all levels;
- Assist the College in developing strategic approaches to understand the fundamental and structural causes behind persistent disadvantage;
- Develop opportunities for students, staff and the wider College community to engage in Social Action endeavours locally, nationally and globally;
- Coordinate and facilitate professional development and workshops focussed on Social Justice, Service and Philanthropy for the staff, students and College community;
- Exemplify the requisite dispositions that reflect an ethos, culture and values system that is underpinned by principles of social justice, service, philanthropy, leadership and democratic processes;
- Identify, actively support and develop, innovative approaches that contribute to systemic change on a local, national and international scale;

- In collaboration with other senior staff, identify and support ongoing and purposeful professional learning opportunities for staff and students about social justice issues;
- Develop sustainable relationships with appropriate not-for-profit organisations that work for fundamental change; increasing opportunities to address disadvantage for those who are less well-off politically, economically and socially;
- Support and participate in College related College programmes, including the year 9 CUE Programme & Big Experience, the STL Food Truck, Sacred Heart Mission, and other Social Justice activities;
- Lead a team to organise the Bangladesh Dinner;
- Network with external community service groups, with the intent of developing new and ongoing partnerships that could be supported by the St Leonard's College community;
- Be aware of contemporary research and thinking which supports the Social Action framework at St Leonard's College;
- Participate in staff meetings, strategic planning, working groups and other activities that enhance and deepen the College's approach and envelopment of Social Action;
- Contribute to, and where appropriate participate in, programs in the College curriculum which provide opportunities for students to volunteer and participate in community service activities;
- Be a positive ambassador for the College in all communications with students, parents, teachers and members of the wider community;
- Support and facilitate student-lead Social Action groups and initiatives across the College;
- Oversee the role of Social Justice Mentors and coordinate their contribution to Social Action across the College;
- Manage the Social Action budget;
- Work with the Heads of House to develop and coordinate House Social Action activities across the College;
- Contribute to the recognition of student contribution to Social Action through Social Action Colours, student assemblies, newsletter articles and other means; promote Social Action opportunities, activities and events to the College community;
- Any other tasks as deemed appropriate.

- Understanding service leadership in an educational environment;
- Strong verbal and written communication skills;
- Strong relationship building skills;
- Proven history and success in leading change;
- Capacity to work independently and as a collaborative team member;
